2022 marks our third year operating under a public health emergency. As the pandemic shifted to an endemic, we adapted to our new environment with a focus on maintaining access to our core services and showing appreciation for our staff. With recruitment and retention as a major focus, we are proud to say we maintained our retention rate and continued to expand our reach to meet the needs of our growing community. We opened a dental suite in Steamboat Springs and strengthened partnerships with school districts to provide resiliency skill-building to all youth in the valley. 2022 also marked year one of our endowment. We launched our Legacy Society and are so grateful to share that through the generous support of our community, we are halfway to our \$1 million goal over 3 years.


