

Stories behind the recognitions

Our staff who provide direct care and services to patients and clients bear witness to positive impacts of our work. Take a minute to talk to one of our providers, and you will hear an inspiring story about how our comprehensive, preventative – and accessible – services make a difference in patients' health and quality of life every day.

Suzanne Holm, nurse practitioner, is particularly proud of one her patients, Jimmy Jensen, 62. When he first visited our Community Health Center in Craig, he weighed nearly 400 pounds and suffered from diabetes, conjunctive heart failure and chronic pain.

He surprised her. The patient started riding a stationary bike 45 minutes every day. Holm encouraged him while closely monitoring his diabetes and pain management. Over the course of 10 months he lost 60 pounds. His A1C, a blood test gauging how well a person is managing their diabetes, improved significantly. His legs were no longer swelling, and he was taking less medication. "His overall state of health and state of mind were so much better than when I first saw him," Holm said.


