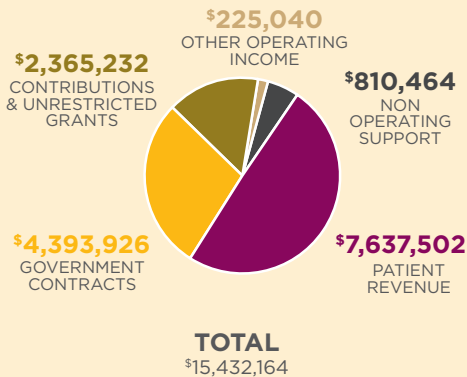

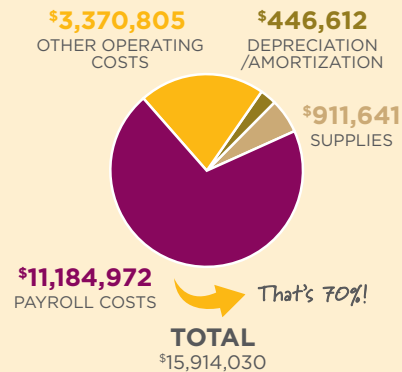

SOURCES OF FUNDING

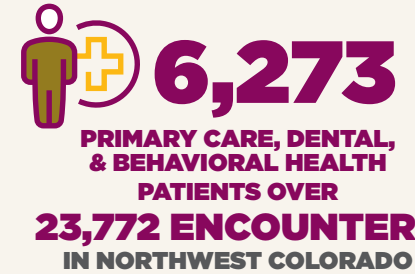


EXPENSES
