Provides homemaking and personal care services to clients in their homes, including housecleaning, meal preparation, laundry, bathing, dietary assistance and meal preparation, and similar tasks.

Works under the general supervision and direction of the CNA Lead and/or designated supervisor.

## **Supervision Exercised:**

# **Essential Functions:**

- 1. Accomplishes job duties in a timely, safe, and professional manner. All procedures require the complete knowledge and use of universal precautions. Procedures which may be required of the personal care provider include but are not limited to any combination of the following:
  - Assists with personal care such as bathing, hair care, assistance with dressing, routine skin care.
  - Assist with toileting to include: assisting the client with relation to bowel and bladder; ambulation to and from bathroom; and/or bedpan or urinal routines.
  - Assist with simple ambulation.
  - Prioritizes tasks in order of importance for safety of client.
  - Performs housekeeping tasks as needed for health and comfort in the client's home.
  - Makes beds, changes and launders linens and bed clothing.
  - Prepares meals.
  - Grocery shopping or household shopping related to the health and maintenance of the client.
  - Accompanies patient to physician/clinic via taxi or client's car per program quidelines
  - Vacuums and dusts.
  - Clean bathrooms.

  - Meets clients needs, within reason, consistent with the agency policies.
